

CryptoFarmers Play2Earn Game Token Sale - Round 1 Terms and Conditions

EFFECTIVE DATE: OCTOBER 1, 2024 LAST UPDATED: SEPTEMBER, 2024

1. Introduction

This document outlines the terms and conditions for the **CryptoFarmers Play2Earn Game Token Sale** (**Round 1**), where **FARM tokens** will be offered for purchase to the public. By participating in the token sale, you confirm that you have read, understood, and agree to be bound by these terms and conditions.

2. Token Sale Overview

Token Name: FARM

Total Supply for Round 1: 2,500,000 FARM Tokens **Token Price:** 0.4 USDT per FARM token

Blockchain: Polygon
Accepted Currencies: USDT, USDC
Sale Start Date: October 1, 2024

Sale End Date: October 20, 2024 (or earlier if all tokens are allocated)

- 2.1 Early Termination

The token sale may end prior to October 20, 2024, if all 2,500,000 FARM tokens are allocated before this date.

- 2.2 Future Rounds

A second round with an additional supply of FARM tokens may be announced at the discretion of CryptoFarmers. The terms and conditions for any subsequent rounds will not be communicated separately. By participating in Round 1, you agree that future token sale rounds, if any, will be subject to the same terms and conditions as outlined in this document, unless explicitly modified by CryptoFarmers.

- 2.3 Vesting Schedule

Tokens purchased during the sale are subject to the following vesting schedule:

- o 20% of the purchased tokens will be unlocked at the Token Generation Event (TGE).
- A 1-month cliff period will apply after the TGE.
- The remaining tokens will be released linearly over 8 months following the cliff.

- 2.4 Purchase Limits

For this round, the amount of FARM tokens that can be purchased per address is limited as follows:

Minimum Purchase: 200 USDT/USDC
 Maximum Purchase: 3000 USDT/USDC

- 2.5 Token Utility

The **FARM token** is a **utility token** used within the **CryptoFarmers Play2Earn Game.** FARM tokens allow players to **buy and sell crops** within the game, enabling users to participate in the in-game economy. FARM tokens are designed solely for use in the CryptoFarmers ecosystem and do not represent securities or investments.

3. Eligibility

- 3.1 Restricted Persons

Participation in the token sale is **NOT** available to individuals or entities who meet any of the following criteria (referred to as **Restricted Persons**):

- Residents, citizens, or entities incorporated or having a registered office in the United
 States of America or any of the following Prohibited Localities:
 - Afghanistan
 - Angola
 - Ghana
 - Guyana
 - Iran
 - Iraq
 - Lebanon
 - Myanmar (Burma)
 - North Korea
 - Palestinian Territory and Gaza Strip
 - Somalia
 - South Sudan
 - Syria
 - Tonga
 - Trinidad and Tobago
 - Uganda
 - Yemen
 - Zimbabwe
- No exceptions will be made to this restriction. If you are a Restricted Person, you are
 prohibited from accessing or using the token sale platform (the Interface) in any capacity.

- 3.2 Prohibited Access via VPN or Other Means

Using virtual private networks (VPNs) or any other methods to circumvent geographical restrictions and access the Interface is strictly prohibited. If you are a Restricted Person, you should not attempt to participate in this token sale by any means.

- 3.3 Compliance with Local Laws

It is your responsibility to ensure that participation in this token sale is permitted by the laws of your jurisdiction. By participating, you represent that you are not violating any applicable local laws.

4. Terms of Use

- By accessing the token sale Interface or purchasing FARM tokens, you agree to:
 - 1. Comply with all applicable local, national, and international laws and regulations.
 - 2. Adhere to the restrictions outlined in this document, particularly regarding prohibited jurisdictions.
 - 3. Accept that your use of the Interface is subject to these terms, which include a **mandatory individual arbitration** and **class action/jury trial waiver**. This provision

requires that all disputes arising from your participation in the token sale be resolved through arbitration on an individual basis, rather than through jury trials or class actions.

5. No Refunds

- By participating in the token sale and purchasing FARM tokens, you **understand and agree that all purchases are final.** There will be **no refunds** or cancellations of token purchases under any circumstances, including but not limited to fluctuations in the value of FARM tokens, delays in token distribution, or changes in the participant's financial circumstances.

6. Arbitration and Class Action Waiver

- 6.1 Arbitration Agreement

By participating in the token sale, you agree to submit any dispute, claim, or controversy arising out of or relating to these terms to binding individual arbitration, rather than to a court of law.

- 6.2 Waiver of Class Action

You expressly waive your right to file any class action or seek relief on behalf of a class of participants in connection with the token sale. All claims will be resolved on an individual basis.

7. Disclaimer of Liability

- Participation in the CryptoFarmers token sale is at your own risk. The FARM tokens <u>are not</u> intended to constitute securities, investment products, or any form of capital investment. By participating, you acknowledge and agree that:
 - The value of FARM tokens may fluctuate, and you may lose the entire value of your investment.
 - CryptoFarmers is not responsible for any loss or damages arising from your participation in the token sale, including but not limited to losses caused by volatility, technical errors, or regulatory actions.

8. Termination of Sale

- CryptoFarmers reserves the right to:
 - 1. Cancel or terminate the token sale at any time, for any reason, including but not limited to regulatory actions or force majeure events.
 - 2. Refuse or cancel any participant's purchase of FARM tokens if deemed necessary for compliance with applicable laws or to protect the integrity of the sale.

9. Changes to Terms and Conditions

 CryptoFarmers reserves the right to update or modify these terms at any time without prior notice. Any changes will become effective immediately upon posting the updated terms on the token sale platform. It is your responsibility to review these terms regularly to ensure you are aware of any updates.

10. Governing Law

- These terms and conditions are governed by and construed in accordance with the laws of the jurisdiction in which CryptoFarmers operates. Any disputes that cannot be resolved through arbitration will be subject to the exclusive jurisdiction of the courts in that jurisdiction.
